Motions: Move to recommend appointment of _____ to the CVTA as Designee for a term commencing January 10, 2022, and expiring December 31, 2023 and of Frank Hopkins as Alternate to the TAC.

Summary of Item: The CVTA, which is made up of the PlanRVA localities, a member of the House of Delegates, one member of Senate and one member of the Commonwealth Transportation Board who reside in a county or city in the CVTA.

The CVTA shall be responsible for prioritizing and allocating regional transportation funding sources to projects within the region.

The CVTA by-laws indicate the primary member shall be the Chair of the Board of Supervisors of the governing body. In the event the Chair cannot attend a meeting, or wishes to have another member represent the County, they may choose another Board of Supervisor member as designee in their place. The County is not required to appoint a specific designee, however for them to attend in the Chair's place the by-laws require the intent to send a designee "*shall be submitted in writing or electronically to the Chair of the Authority at least forty-eight (48) hours prior to the affected meeting.*" This may not always be feasible, for example if the absence is due to a sudden illness. By appointing a designee and informing the CVTA in writing, no further notice shall be required for that person to attend in place of the Chair when needed, even within 48 hours of a meeting. Bret Schardein is the primary staff member to TAC, there is currently no staff alternate.

With two primary representatives for the Board, the alternate position has remained vacant for several years, as it is unlikely that at least one of the two primary members will not be able to attend a meeting. However, it is an available position if the Board wishes to fill it.

The terms of office of commission members who are also members of governing bodies shall be coincident with their elected terms of office. The terms of office of commission members who are also members of the local planning commission shall be coincident with their appointed terms of office as members of such planning commissions. The terms of alternate members shall be coincident with the elected terms of office of their designated member of the governing body.

PlanRVA is a regional planning agency with major emphasis in the areas of transportation, water resources and solid waste planning, local technical assistance and information services including demographic, economic and geographic information systems. The Planning District is comprised of elected officials and citizens who address mutual problems and find solutions for the local governments which benefit from intergovernmental cooperation.

Karin Carmack and David Williams are the primary members, with terms running through 12/31/2023. Bret Schardein is the staff appointee to TAC. There is currently no staff alternate on TAC. The Board may appoint two other Board members as alternates. With two primary representatives for the Board, the alternate positions have remained vacant for several years, as it is unlikely that at least one of the two primary members will not be able to attend a meeting. However, they are available positions if the Board wishes to fill them.

Members duties and responsibilities include attendance at regularly scheduled meetings, special meetings and advocating for the needs of the low-income population. The PCAAAB will work with other Agencies in the county to help solve the problems of the low-income residents. Members may serve up to two four-year terms.

Beverly Funn's term is a representative of an elected official expired on 12/31/2021 and has served two terms and thus cannot be reappointed. Wayne Boese's term expires 2/28/2022 and has only served one term and may be reappointed. Kathy Walkin's term expires 3/31/2022 and has only served one term, thus may be reappointed.

STANDARDS OF CONDUCT

Recognizing that persons holding a position of public trust are under constant observation by the media and interested County residents, and recognizing that maintaining the integrity and dignity of the public office is essential for maintaining high levels of public confidence in our institutions of government, every member of the Powhatan County Board of Supervisors agrees to make his/her best effort to maintain the following Standards of Conduct:

1. Avoid during public meetings and during the performance of public duties the use of abusive, threatening, or intimidating language or gestures directed at colleagues, citizens, or personnel.
2. Pay all taxes due to the County, state, or national government.
3. Attend all regularly scheduled meetings of the Board or assigned committees, resigning whenever personal circumstances preclude regular attendance.
4. Avoid choices and behaviors that cast public doubt upon the integrity and competence of the County Government.
5. Make a conscientious effort to be well prepared for each meeting.
6. Avoid criticism of colleagues or County employees in public places or open meetings; have conversations of this nature only in private meetings or in closed session with the appropriate individuals.
7. Work to create a positive environment in public meetings where citizens will feel comfortable in their roles as observers or participants.
8. Maintain an attitude of courtesy and consideration toward all colleagues and staff during all discussions and deliberations.
9. Be tolerant. Allow citizens and employees sufficient opportunity to present their views.
10. Be respectful and attentive. Avoid comments, body language or distracting activity that conveys a message of disrespect for the presentations from citizens, personnel or colleagues.
11. Be concise. Avoid the practice of taking more time to address an issue before the body than is necessary and essential for an adequate consideration of those matters being discussed.
12. Maintain confidentiality of personnel matters and all matters discussed in closed session.
13. Board members shall not use county employees for personal matters.
14. No supervisor shall directly contact a county employee without notifying the county administrator (via email, text, or voice mail) of the intended contact and intent of the conversation.
